CCRSPA MINUTES – May 21, 2024

Our meeting was called to order by our president Mary Ellen Butkiewicz. Bill Ide addressed benefits. This involved presenting Joanna Zimmerman and Briane Crouse. There were discussions of the Benefits Advisory Committee (BAC). This group helps: Support Services, Teachers, Administration, Supervisors (ASA) It also helps in the making of business decisions. The members meet four times a year. Twelve people plus Bill Ide vote for changes, such as our dental plan and the new RSP for vision next year. Self-insured means the employer owns the insurance. When you get a bill with remaining costs, CCPS pays that remaining amount. We pay the rate and deductible, CCPS pays the rest. Payroll and healthcare are the most expensive items being paid by CCPS. Out of pocket expenses are the same for Aetna and Care First with a ceiling of \$1500 per policyholder. CORRESPONDING SECRETARY: Thank-yous were given to Catherine Duckett and Reg Canaday for their charitable contributions. COMMUNITY OUTREACH: The third delivery for this school year was made. The school nurses are so thankful for these muchneeded items for the children. There is a combined total of 3,000 volunteer hours by members of our chapter. Barbara Buck has the most volunteer hours. She has participated in such activities as; Cecil Cares Clean-up Program, church Sunday and Bible Schools, cleaning for missionary visitors, and many more. Congratulations and thank-you, Barbara, for your dedication and hard work.

Consumer Ed.: Linda Elwood reported that there is no additional money for the grant program. It is not good at the state level. Services have been cut. There are ten medicines (mostly for diabetics) that are on a list to become more affordable.

LEGISLATIVE REPORT

This year's Legislation Session has ended and unfortunately there were not a lot of changes due to this year's budget shortfall.

Ten of the bills our committee supported, passed and were sent to the Governor for his approval. Twelve bills we opposed failed. We opposed HB1386 - Education - School Employee Antibias Training - Requirements. This bill passed and was sent to the Governor. It would develop guidelines and training for teachers.

Bills we supported, passed and were sent to the Governor are:

SB0143/CH0065 - Teachers' Retirement and Pension Systems - Reemployment

SB0202 - Department of Aging - Caregiver Expense Grant Program - Established -This bill started out as a tax credit, but ended up allowing caregivers to apply for a grant.

SB0219/CH0048 - Senior Prescription Drug Assistance Program - Sunset Extension - There will be a limit on the amount of money that will be given.

SB0744 (HB0814) Juvenile Law Reform - A general feeling that this bill does not go far enough to punish juveniles.

HB1143 - Emergency Medical Services - Maryland Emergency Department Wait Time Reduction Commission - Establishment. This commission will address factors that increase wait time. Unfortunately, private equity firms are getting involved and are interested in making money. They want to cut staff and hire more Physician Assistants instead of Physicians.

The General Assembly leadership decided to wait and expand our Prescription Drug Affordability Boards Authority until it completes its initial phase. This bill will reappear January 2025. The Board announced the first prescription drugs they will consider for cost review will include Biktarvy, Dupixent, Farxiga, Jardiance, Ozempic, Skyrizi, Trulicity, and Vyvinse. Finally, a bill SB0001 (HB0267) Electricity and Gas - Retail Supply - Regulation and Consumer Protection passed and was sent to the Governor to sign. Our committee agreed to send a letter to Governor Moore requesting him not to sign this bill. We have been warning our members to not go with third party electric companies that target seniors and residents in poor neighborhoods. These electric companies initially offer lower rates, but after several months their electric rates substantially increase. AARP has worked hard to inform the public about this issue.
